# **Study Leave**

# for Foundation doctors

The Scotland Deanery operates a national process and system to ensure that all applications for study leave are considered on a fair, equitable and consistent basis. All applications are made through Turas TPM (the NES online training management system). The <u>Policy and Operation</u> <u>Guide</u> is available on the website and the BMA have been consulted and contributed to the support of the policy.

# FY1

FY1s do not have a formal study leave entitlement other than to attend the Mandatory Delivered Education Programme and any courses organised by the Deanery (ILS, simulation etc.) You may use 5 days as taster leave within the last post of FY1.

# FY2

In FY2 you can apply for study leave for a selected number of reasons. These are detailed on the <u>website</u>.

FY2s have 2 days for eALS and up to 5 days for Tasters. This study leave is non-transferable and can only be used for these purposes. Taster time can be taken in either the third block of FY1 or the first block of FY2. It would usually be taken as 5 days for each specialty/GP area. Tasters are usually taken in your own region unless the clinical specialty isn't available locally. Please see the <u>advice on tasters</u> on the website for further information.

Of the remainder, much is taken up with your Mandatory Delivered Education Programme and simulation training. All the funding available for FY2 study leave is used to fund the eALS course and simulation training.

Further Study Leave days may be available for appropriate Study Leave. You may apply for time to attend postgraduate exams but not courses to enhance your application. Study Leave in Foundation can only be used to satisfy your completion of the Foundation curriculum. You are entitled to leave for interviews however this should be taken as service leave; you are contractually entitled to this however you must give adequate notice.

# **Study Leave Application Process**

Firstly you should request leave from the service and then submit a request on TURAS for your FPD to approve. This should be submitted six weeks in advance of the leave date. If you are uncertain as to whether this is appropriate use of study leave please contact your FPD for advice in advance of the application. # **Preparing for Specialty Recruitment**

The recruitment application window for ST1 and CT1 posts opened at 10am on 7th November 2018 and will close at 4pm on 29th November 2018. Please see the <u>Scottish Medical Training</u> website for details and links to the speciality recruitment person specifications. Posts and programmes are advertised on <u>Oriel</u> and most core/speciality interviews take place in January and February – please keep an eye on your Oriel account.

## **Broad-Based Training Programme**

Scotland will again be recruiting to the **Broad Based Training programme** which offers a firm foundation in four specialties with direct entry into year two of each of these specialties. The programme includes six months in each of the following specialties; Internal Medicine Training, General Practice, Paediatrics, Psychiatry. During each of the four attachments, 10% of training time is spent in one of the other three specialties. The programme allows time and confidence to develop before having to progress to a further career choice, whilst still gaining GMC training recognition. The training provides an integrated approach across disciplines, and allows direct entry into second year of training in any of the four specialties without further interview.

## **Planning for success**

This is the time to plan how you are going to make yourself competitive for the post you want. Consider the number of QI/ audit projects you have done. Try to make sure they have relevance to the proposed specialty. Remember you should consider re-audit/close the loop or evaluate your QI project. Keep evidence of teaching schedules where you present and always request written feedback on your performance.

## **Tasters**

You should think about planning a taster session. The Foundation School expect that you will undertake tasters in your own region. We will not approve a taster outside your region unless your region does not offer that specialty. Tasters cannot be done overseas and are not opportunities to get yourself known in your preferred department. The exception to out-of-region tasters is for remote and rural GP tasters. Your first step is to secure leave from your department then apply though Turas for study leave. You should co-ordinate this by approaching the department you wish to visit to make sure it is suitable for them. If you are having trouble organising this your FPD can help. You should consider asking to meet the TPD for the specialty as they have access to career advice in their specialty. Further information about tasters can be found <u>here</u>.
