It provides an opportunity for peer sharing and learning, senior support and an avenue to voice practical workplace concerns.

# **ARCP Requirements**

Due to COVID-19 disruption, derogated requirements currently apply for ARCPs until September 2021. This is due to the recognition that training and teaching may have had some disruption.

The Scottish Foundation School have agreed that evidence for all Annual Review of Competence Progression (ARCPs) must be submitted by 31st May 2021.

It is your responsibility to ensure that your Turas Portfolio is up-to-date and that all your evidence is complete and you have recorded your teaching correctly.

For advice on your ARCP you should speak with your Educational Supervisor and/or your Foundation Programme Director as the first point of contact for their guidance on the revised requirements.

#### What is the ARCP?

The ARCP is a review of evidence of achievement over the course of a year in training. The ARCP panel reviews and validates the recommended outcome against your Turas Portfolio. Although the ARCP is not in itself an assessment, it is a summative judgement of a Foundation doctor's performance and development throughout the year. Progression is dependent on evidence that the Foundation doctor has met or exceeded the minimum expected level of performance in each of the 20 Foundation Professional Capabilities.

#### What date is my ARCP?

A member of the Training Management Team will have emailed you with the date of your ARCP. The 2021 ARCP dates can also be found <u>here.</u>

#### After my ARCP, what do I need to do?

You will be notified of your outcome via email. Please log onto your Portfolio to sign your ARCP form.

#### I am an F1 - what happens next?

F1 trainees who successfully complete their F1 year and achieve an ARCP Outcome 1 will be issued with a F1CC (Foundation Year 1 Certificate of Completion). You must have a F1CC to allow you to apply for full registration with the GMC. Your F1CC is generated electronically once you have signed your ARCP Outcome 1. The F1CC is signed digitally and stored in your Turas Portfolio. There is no paper copy of this certificate.

#### I am an F2 - what happens next?

F2 trainees who successfully complete their F2 year and achieve an ARCP Outcome 6 will be issued with a FPCC (Foundation Programme Completion Certificate). You must have a FPCC before you start Speciality Training. You may be asked to produce a copy of this certificate to your future employer. The FPCC is signed digitally and stored in your Turas Portfolio. There is no paper copy of this certificate.

#### Can I download my portfolio/evidence?

Yes, this can be done at any point during your training by selecting Download from your menu bar.



In February 2021 the Scottish Foundation School supported the creation of a Scottish Foundation Trainees Forum. This group brings together local trainee reps from each region including F1s, F2s and trainees who are on the Academic Programme. This enthusiastic group of trainees meet regularly to discuss regional and national issues and to share good practice. The minutes from this forum are sent to the Scottish Foundation Board which is attended by at least one trainee rep who provides feedback from across Scotland. Trainee reps also attend several other Scottish Foundation groups such as the Foundation Curriculum and Assessment Implementation Group and the Foundation Academic Group. Trainee reps are a key element in developing and monitoring the Scottish Foundation programme and representatives play a valuable role in providing feedback to Scottish Foundation meetings. It is expected that trainee reps will help to shape new initiatives through their involvement in these groups.

The trainee reps may also canvass/survey trainees to gauge feedback on key matters with the aim of providing data and comments to share with the Foundation meetings. Some of the trainees reps also attend UK Foundation meetings where they can hear what is happening across the UK and feed in from the Scottish perspective.

Ideally the trainee reps will help improve the lines of communication been the Foundation School and the trainee cohort by conveying trainee opinion and disseminating information from national meetings through their local networks. You can contact your local trainee reps at any time.

Victoria Holdstock, one of the F2 reps, says: "Each region has foundation trainee representatives who are a point of contact for questions and feedback (both positive and negative) raised by Foundation doctors. These trainee reps meet regularly within regions and attend Scottish Foundation School meetings to represent the view of Foundation doctors at a national level, which allows good practice to be shared and changes to be made when issues are identified.
